Will not give any medication to the rescue Boxer without the designated OBR veterinarian's approval, or the approval of an OBR Director_____

The boxer is not good around cats

The boxer is not good around female dogs

The boxer is not good around male dogs

Acknowledges that the boxer's temperament is not truly known and will exercise caution at all times in the handling of the dogs_____

Acknowledges that since OBR representatives will not be the ones observing the dog in the foster home environment, drawing conclusions and making decisions about the dogs lifestyle, behavior, ext, OBR cannot & will not take legal or financial responsibility for anything the dog does while in the care of the foster home_____

Acknowledges that the boxer is the property of OBR and is never to be given, leased or sold to any person(s), laboratory or business_____

Acknowledges that there is no monetary compensation for fostering or transporting the boxer and that fostering is strictly voluntary_____

Acknowledges that the rescue boxer will not be abused or treated cruelly and will not be the subject of any type of experimentation_____

Will permit prospective adopters & an OBR representative to visit the foster home to view the rescue boxer or will transport the rescue boxer to a location for such a meeting_____

Will fill out a provided form outlining the personality traits of the foster boxer to the best of their ability to enable OBR in determining the best home possible for the boxer
